Maximum Production Investment - 20 MMBF/Year

Plywood / Particle Board: \$0.0456 Msf
Maximum Production Investment - 52,631 Msf/Year

Hardboard/Veneer: \$0.03 Msf
Maximum Production Investment - 80,000 Msf/Year

Roundwood Pulpwood: \$0.0456 / Cord
Maximum Production Investment - 52,631 Cords/Year

Chips: \$0.072 / Unit (2,000 lbs.)
Maximum Production Investment - 33,333 Units/Year

Pulp/Paper: Groundwood Pulp - \$0.0456 / Ton
Unbleached Kraft Pulp - \$0.0816 / Ton
Maximum Dues Investment - \$3,600 / Year
